Release Types

1. Release on Own Recognizance (ROR) - No Conditions
2. Release with Conditions: PRL1, PRL2, PRL3, PRL4, PRL5

Pretrial Release Conditions

1. DEFAULT

- Report your contact information and any change in address, phone or email to the Court and your attorney within 1 business day of the change
- Promise to appear for all required court proceedings
- Promise to not commit any criminal offense

2. DV

- Must sign Jail Release Agreement, or remain in custody and be brought before a judge for a decision on Jail Release Order conditions

3. ROR

- Report your contact information and any change in address, phone or email to the Court and your attorney within 1 business day of the change

4. PRL1

- Where available, 1 phone contact per month or equivalent
- Where available, Court reminder notification

5. PRL2

- Where available, Court reminder notification
- Where available, 2 phone contacts per month

6. PRL3

- Where available, 1 face to face contact per month
- Where available, Court reminder notification

7. PRL4

- Where available, Court reminder notification
- Where available, 1 face to face contact per week

8. PRL5

- If statutory requirements are met (Utah Code 77-20-201), hold without bail. If released, maximum conditions recommended (and/or monetary bail).

9. OPTIONAL

- DEFENDANT MAY BE RELEASED ON AN UNSECURED BOND
- Appear in court when required
- Avoid contact with the victim(s) of the alleged offense
- Drug testing
- Commit no new offenses during the period of release
- Electronic monitoring
- Defendant shall forfeit or refrain from possession of a firearm or other dangerous weapon.
- Home detention
